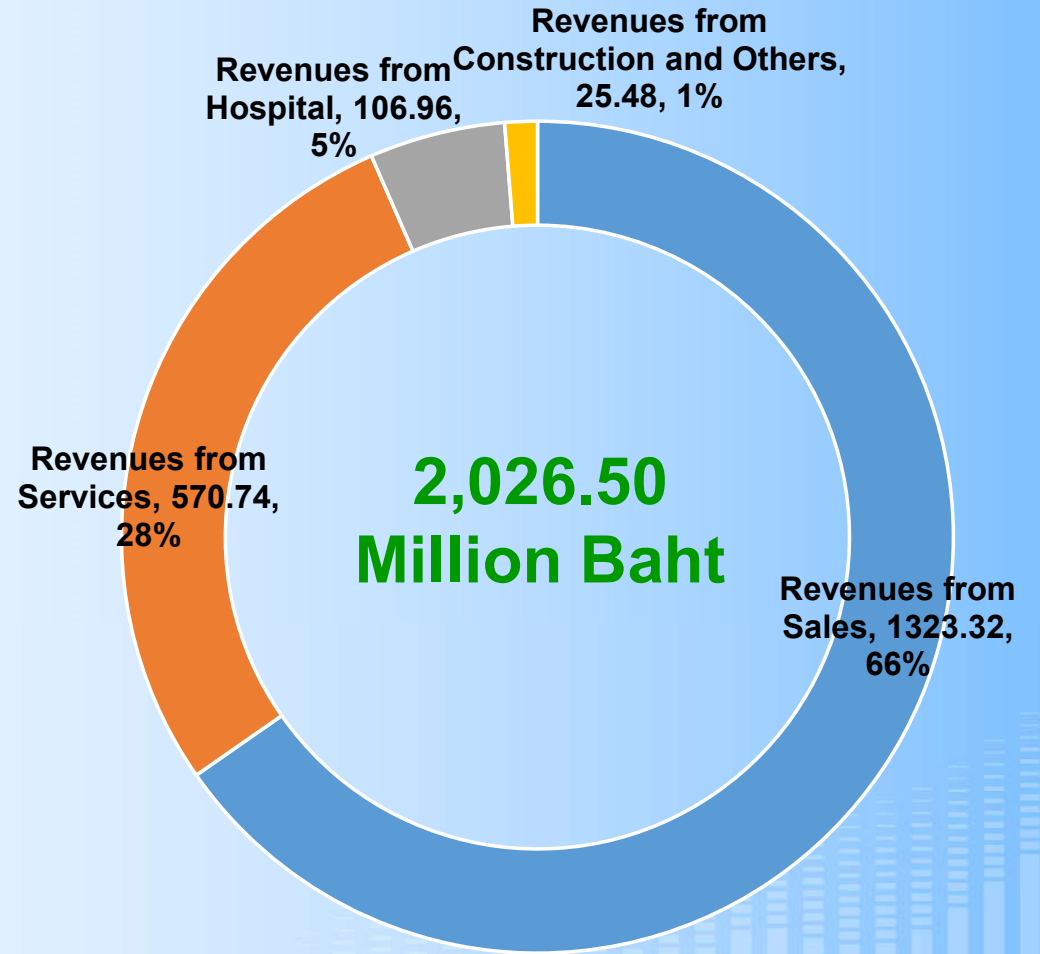

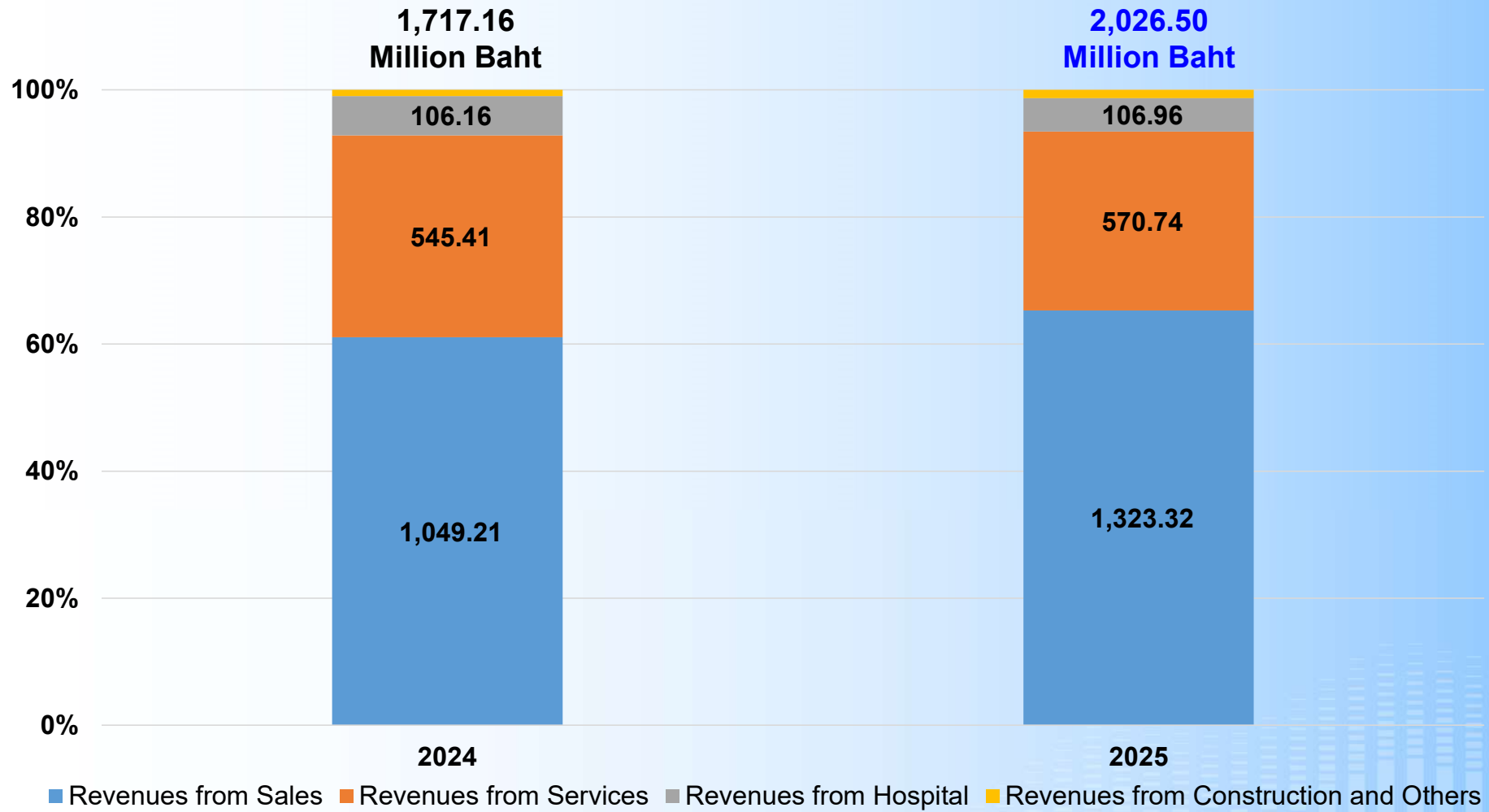

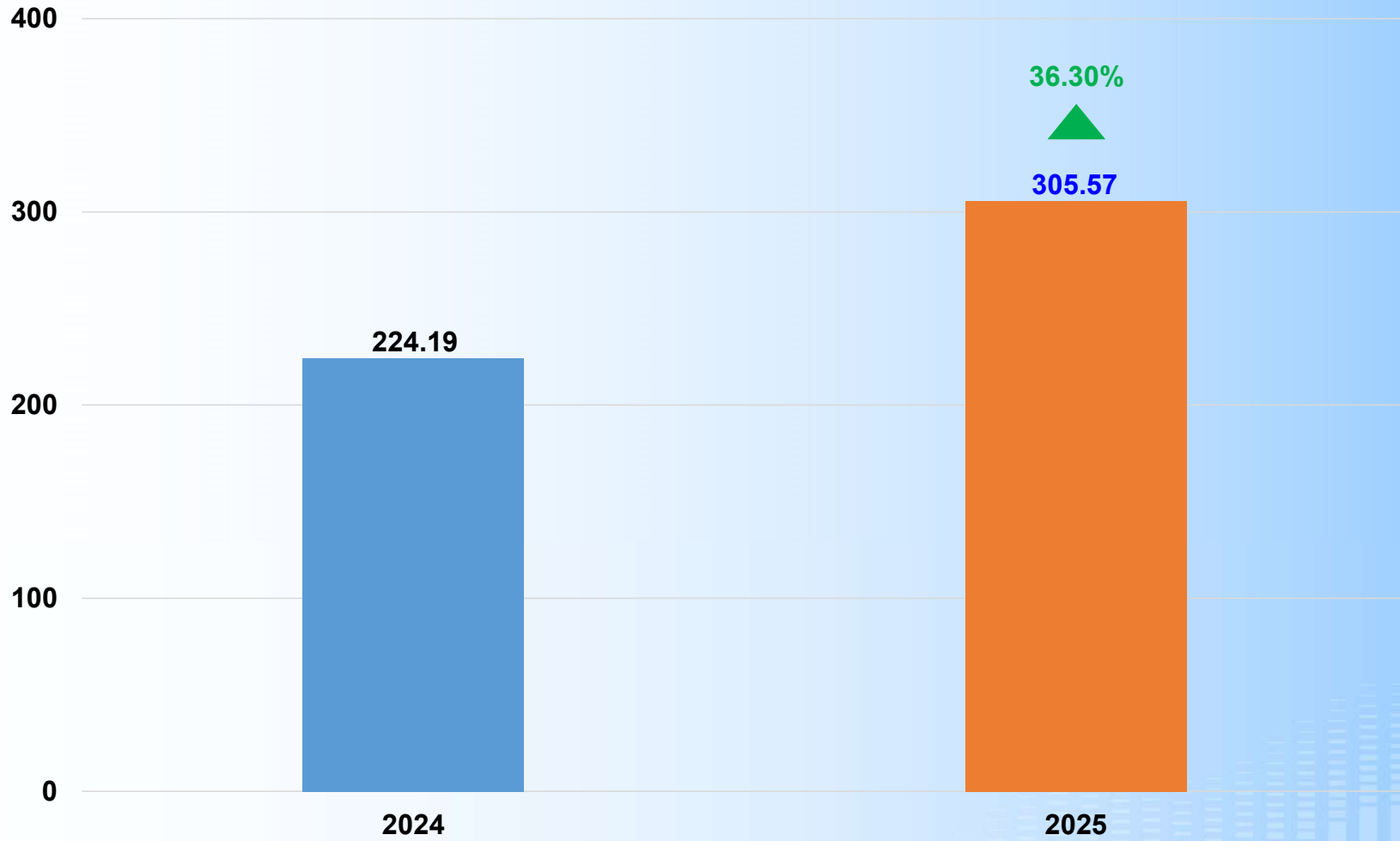


# Revenue Contribution



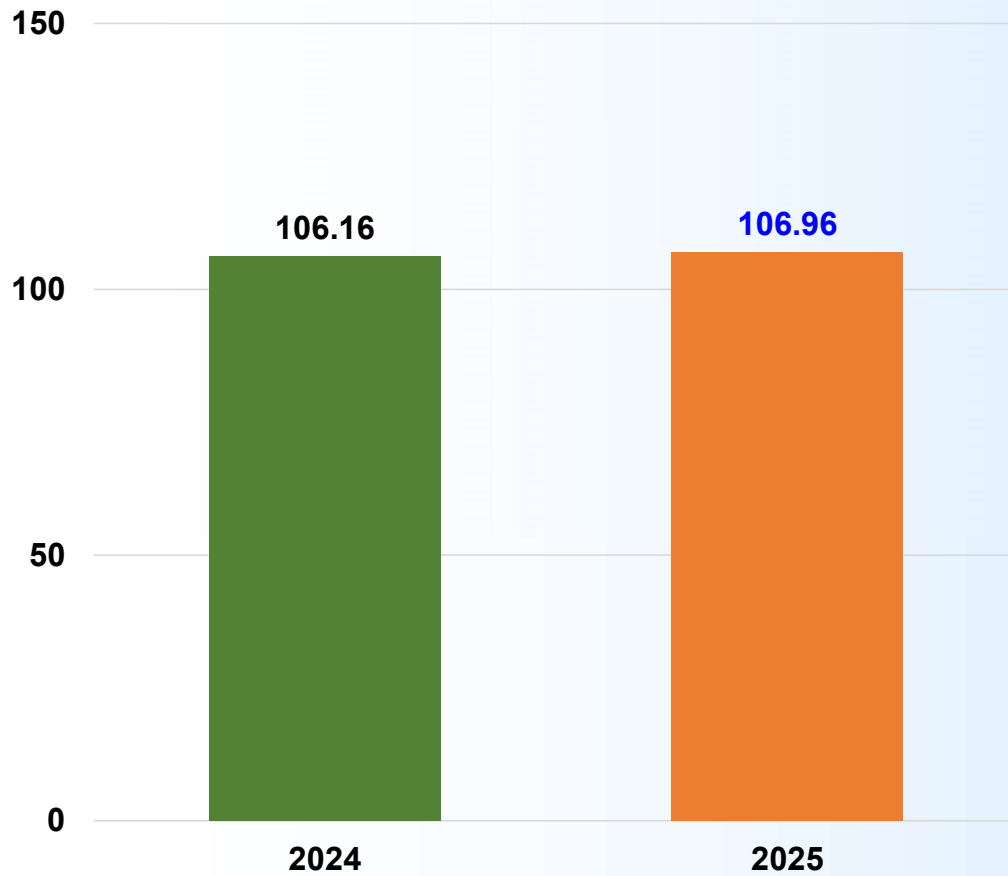
# Net Profit

# Revenue from Hospital

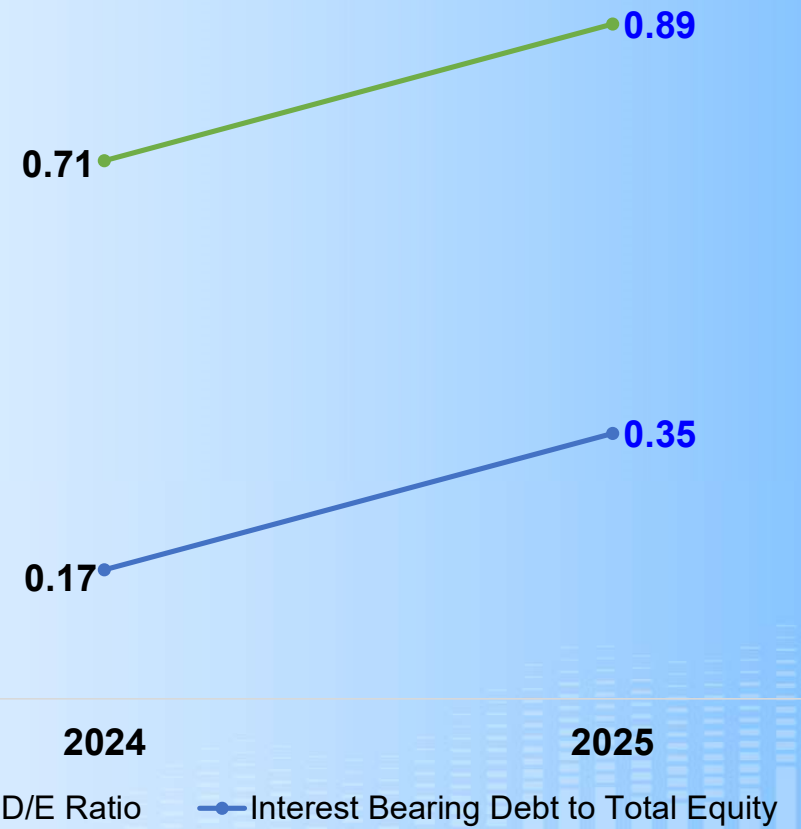
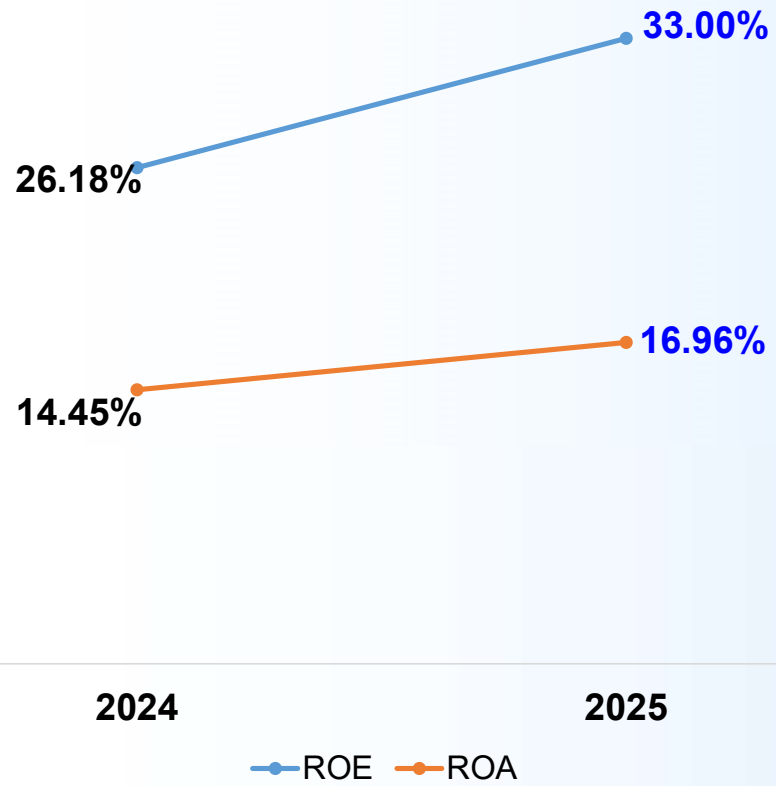
